




Q2 What is your cultural background?\*


Q3 Are you currently doing any educational studies?\*







Q6 Why did you choose to work from a legal brothel?\*





We have less agency about who comes to meet us, abusive clients are not banned (our safety is less valued than owners money). or giving half my earnings to a brothel for a perceived sense of safety (even though it still can be unsafe in legal brothels and I have less agency).

- High room hire rates charged by brothels, resulting in over 50% of the fee going to the brothel
- Not being able to determine own rates for standard service!!!!!
- Not being able to choose clients based on how much they're offering (e.g. having to take a client offering standard service because they pre-booked over the phone, while another client who wants to book you is interested in multi-hour gfe). This lack of choice can greatly effect overall income. Allowing choice from the provider based on potential earnings may incentivise increased spending from the client.
- Pressure from managers to intro and/or provide to clients we don't want to service
- Pressure to stay on shift when feeling unwell or not up to working. This may be from managers, a lack of other workers on shift, or other reasons.
- Clients often don't understand the nature of services due to the fast turnaround time between them entering the brothel and beginning their appointment, and service providers expecting that the client knows what type of service they're asking for e.g expecting gfe when requesting a standard. When working privately, services can be fully outlined so the client know what to expect ahead of time.




Q13 Have you ever worked as a sex worker in a brothel in New South Wales,


Q14 Have you ever felt pressured by a Queensland legal brothel to provide a service to a client?\*


Q15 Have you ever felt pressure to provide a service to client when working outside of a Queensland legal brothel?


Q16 Do you feel safer in a Queensland legal brothel compared to other states or other work places?\*


Q17 Did your current Queensland legal brothel preformed training and an induction with you?\*


Q18 What training did you receive at the commencement of work at your current Queensland legal brothel?\*


Q19 Do you feel that the training and information you received was sufficient?\*

Q20 In the past 12 months have you been contacted by, received information from, received assistance/training from or attempted to contact any Industry Association?\*







**Q25** Do you believe that if Licensed Queensland brothels could offer outcall services that this would result in a better and more financially rewarding outcome for yourself?




**Q26** Are you happy that Licensed Queensland brothels treat you as an independent sole trader?\*




Q28 If the sex industry was deregulated, where would you prefer to work?\*
